Our ACTIONS in 2013

The <u>AlterSummit</u> is a recent movement, founded in 2012. In 2013 we welcomed number of new member organizations (<u>Who we are ?</u>) clarified our <u>functioning rules</u> and, above all, more than 1000 leaders and activists from 20 countries gathered in Athens for a <u>first summit of European peoples</u>. The main outcome of this summit is the Athens' <u>Manifesto</u> Also several thematic assemblies worked on <u>their strategy</u>.

Our CAMPAIGNS in 2014

In late October, a meeting of the network has made clear <u>our goals</u> for 2014. In particular, the organizations agreed to focus on <u>three targets</u> representing the worst dangers to our social and democratic rights. On each of these targets, strategic thinking is in progress, based on an initial proposal that you will find attached:

- A against the Transatlantic Treaty
- Lurope against austerity and the dictatorship of the Troika
- A against the rise of the far right and fascism

Action of our Networks and Partners:

- The Blockupy 2014 preparation conference was held in late November: echoes of this work <u>Blockupy-Frankfurt</u>
- The network against evictions housing met in Paris on December 6
- A strategy seminar against the TTIP (Transatlantic Treaty) took place in Brussels on 12th & 13th December.

Our next APPOINTMENTS:

December 2013:

- Wednesday, December 18: Belgian Altersummit coordination organizes with the d19-20 alliance, a European meeting in the auditorium of the of international trade unions house, 18 to 21:30 program.
- Thursday, December 19: blockade of the EU summit: the d19-20 alliance and several Belgian AlterSummit organizations will occupy the crossroads giving access to the European quarter from 7am, to oppose the summit and reiterate our opposition to the TSCG Treaty and the transatlantic Treaty.
